## **Estates Practice**

- Preparing trusts for younger beneficiaries or loved ones who just don't know how to handle money,
- Preparing a trust to provide for a cherished pet during it's lifetime,
- Anticipating the costs of long term care as we age and planning for the preservation of your estate for your children (often called Elder Law),
- Providing for NFA Firearms that may be part of your estate, including an *inter vivos* trust in your lifetime,
- Issues including the continuation of a business post-death should a key participant pass on.
